



## 1. Laundry Services

One of the striking features of PRINCE VILLA is its Laundry Facility, which is a complimentary service for the boarders. Laundry person comes to the hostel once every week to collect the dirty cloth. Within a span of one week, he returns with all cleaned and ironed cloth, ready to wear.

- 1.1 Please do not hand over your expensive garments containing heavy work.
- 1.2 Boarders are not supposed to give winter wears, blankets and blazers. If at all you give any of the above, extra amount will be charged for the same.
- 1.3 Please set apart the garments that shed color in order to prevent damage to other cloth.
- 1.4 Dry Wash facility is available on extra charge paid by the boarder.
- 1.5 Boarders are advised to collect their cloth immediately after the indication by the hostel staff.
- 1.6 Neither hostel authority nor the hostel superintendent is responsible for the loss / damage of cloth.
- 1.7 For any loss/damage boarder himself has to settle down the matter with the laundry personal. If the laundry personal agrees for any compensation, you need to take it in writing from them.

## 2. Internet (Wi-Fi)

Wi-Fi is a complimentary service for the boarders. Wi-Fi is provided to you for browsing, to help in your study.

- 2.1 Tampering/resetting the modem/router is punishable.
- 2.2 In case of failure of Wi-Fi, boarder himself can lodge a complaint to the service provider. The customers ID of the respective rooms are given below.

- 2.4 After lodging a complaint probably the problem will be rectified within 24hrs.

## **5. Vacations / Holidays**

- 5.1 Each boarder should pack his luggage and hand it over to the hostel warden before going for the summer break.
- 5.2 The keys of the respective rooms should be submitted to the warden before leaving the hostel premises.
- 5.3 PRINCE VILLA is not responsible for the safety and security of the boarder once he leaves the hostel premises.
- 5.4 Boarder, when coming back from his home / LG's home, should bring REJOIN FORM duly signed by his parent/LG stating the date and time of his departure and expected date and time of reaching to the hostel.
- 5.5 Boarders who enroll themselves for any summer training or vocational training will be allowed to stay during the vacation for which they have to submit a copy of their admission form related to the training.

## **6. General Rules and Regulations**

- 6.1 Boarders are expected to be in their rooms other than any valid reasons without prior permission.
- 6.2 The boarders may be allowed to go outside at their own risk and the Hostel authorities are not liable for any incidents during their stay outside the hostel.
- 6.3 The boarders may be allowed to go to their residence after submitting an application duly countersigned by the guardian clearly indicating the purpose of visit, period of stay etc.
- 6.4 The hostel warden after being satisfied with the purpose of the visit has to approve the application and unless the same is approved, the boarder cannot go out of the hostel.
- 6.5 While coming back from their residence after the expiry of leave, they should obtain one letter from the Guardian/Father/L.G, stating the time and date of their arrival at home and the time and date they left their home for the hostel. The format of the letter is given in this prospectus.
- 6.6 All types of intoxications are strictly prohibited inside the hostel.
- 6.7 The warden is not responsible for any type of accident or hazard occurred to the boarders inside or outside the hostel.

- 6.8 If any boarder wants to study after 12.00 midnight or before 5.00 AM, he will use his own table lamp for reading purpose.
- 6.9 In case of any emergency, the warden may give a short notice to the boarders to vacate the hostel.
- 6.10 Boarders are allowed to keep their two wheelers that should be parked within the campus in the specified area. A copy of driving license should be submitted beforehand.
- 6.11 Boarders should report to the hostel warden in case of any complain / problem. They may write an application and submit to him in order to reach to the higher authority.
- 6.12 The boarder is responsible for safe keeping of his belongings inside the hostel.
- 6.13 Neither the authority nor the warden is responsible for the loss / damage of any belongings of the boarders.
- 6.14 The Hostel authority/superintendent has got the right to open any locked room and search at any time without any notice to the boarders or assigning any reason thereof.
- 6.15 Using heater, iron and other electrical appliances are strictly banned in the hostel.
- 6.16 Guests/Friends are not allowed to stay in the hostel without prior permission.
- 6.17 Hostel authority has rights to stop/resume complimentary services at anytime without prior notice.

## **7. Breach of Regulations**

- 7.1 Absence from the hostel without leave application and prior permission.
- 7.2 Lack of cleanliness and tidiness in the room.
- 7.3 Spitting in room, verandah and any other area which shall affect the cleanliness of the hostel.
- 7.4 Misuse of energy, tampering with study table, computer, laptop and other belonging in the room.
- 7.5 Writing and disfiguring the walls doors windows or any part of the hostel.
- 7.6 Misbehavior with any boarder or staff of the hostel.
- 7.7 Allowing any outsider / guest to enter the hostel without due permission of the warden.

- 7.8 Damaging any property of the hostel.
- 7.9 Disrupting silence during study hour.
- 7.10 Creating noise in room.
- 7.11 Forming groups, unions, holding any meeting without permission.
- 7.12 Throwing away dirt or articles outside the window.
- 7.13 Sitting on the roof railing.
- 7.14 Tearing of the newspaper or magazines.
- 7.15 Cooking inside rooms.

*Hostel authorities has the power to maintain order and discipline within the hostel premises and has the power to suspend any boarder for disturbing hostel discipline as stated above or can report the matter to appropriate authorities for necessary action.*

## **8. Penalties and Fines**

<b>8.5</b>	Meeting without involvement of management	Rs.500
<b>8.6</b>	Celebrations without any prior permission	Rs.100
<b>8.7</b>	Putting plates / eatables outside the garbage bin	Rs.100
<b>8.8</b>	Keeping room dirty (Fine to the concerned boarder)	Rs.200
<b>8.9</b>	Throwing dirt outside the window	Rs.50
<b>8.10</b>	Misuse of electricity	Rs.200
<b>8.11</b>	Sitting on the roof railing	Rs.100
<b>8.12</b>	Using iron, immersion rod, heater etc	Rs.200
<b>8.13</b>	Consuming alcohol or smoking inside the hostel	Rs. 5000

*The above penalties will be imposed immediately when any boarder is found to be guilty. The copy of the fine detail will be mailed to the parents of the concerned boarder.*

## **9. Booking**

An amount of Rs. 5000/- (*Non Refundable*) is to be paid along with completed application form, in order to book the respective seat. The seats will be allotted on first come first serve basis. The candidate has to select among the various payment plans mentioned in the Hostel Fee Detail.

## **10. ANNUAL PLAN**

The balance fee can be paid maximum in two installments at the interval of four months according to the following schedule.

Installment I	20th June
Installment II	20th Oct

- 10.1 In case of failure of the deposit of the first installment by the due date, the seat will be allotted to the candidate who will be in priority in the waiting list.
- 10.2 In case of failure of deposit of the second installment by the due date, an amount of Rs.25 will be charged per day which will be deducted from the caution deposit. The boarder may continue only till the caution money exhausts after which the seat of the concerned boarder will be cancelled.
- 10.3 No amount will be refunded if the boarder leaves the hostel before termination of the annual agreement.

## **11. MONTHLY PLAN**

Boarders who are availing the monthly payment facility are supposed to pay the rent at the beginning of the month (within 5th of every month). Failing to which cost you a fine of Rs. 25/day.

- 11.1 There should be at least one month of notice period from boarder side in case of leaving the hostel permanently, otherwise caution money will not be refunded at all.
- 11.2 Boarders are supposed to pay the rent of notice period, the caution money will be refunded only after completion of notice period, and it cannot be adjusted in the monthly rental.
- 11.3 The hostel authority has rights to change in monthly hostel fee at a notice of one month.
- 11.4 Leaving the hostel permanently before completion of the agreement period will be consider as breach of agreement and boarder will have to pay the rent of the entire agreement period before leaving the hostel premises.

- 11.5 The rent is due on the 1<sup>st</sup> day of the every month for the boarders who join on any day before 15<sup>th</sup> day of the month.
- 11.6 The rent is due on the 15<sup>th</sup> day of the every month for the boarders who join on any day after 15<sup>th</sup> day of the month.

All payments will be accepted in terms of Demand Draft only. The Demand Draft should be in favor of GURUKUL, payable at Bhubaneswar. Candidates are instructed to write their names on back of their demand draft.
